# **ELECTION PROCESS**

### **Nomination**

- i. Each member is given an opportunity to nominate a fellow member for election.
- ii. The person nominated must accept the nomination by completing the 'Acceptance of the nomination' section on the nomination form overleaf.
- iii. All forms must be returned to the Principal Officer by no later than 19 July 2023.
- iv. You may not nominate yourself.

# 2. Curriculum vitae

Please ensure that the nominee submits a one-page curriculum vitae (CV) for each nominated member to the Principal Officer by no later than 19 July 2023.

## 3. Acknowledgement of responsibility

The person you nominate must be aware of the following duties and responsibilities of a Trustee, as governed by the Medical Schemes Act of 1998. The Trustee should:

- i. be familiar with the Medical Schemes Act;
- ii. have sound knowledge of the rules of the Fund;iii. have sound knowledge of the financial position of the Fund;
- iv. be familiar with the benefit structure and contributions of the Fund;
- v. act in the best interest of the Fund and according to the registered rules;
- vi. avoid conflict of interest;
- vii. be impartial not base decisions on personal preferences; and
- viii. actively consider decisions.

Please note that if the 'Acceptance of the nomination' section of the nomination form overleaf has not been completed and signed, the nomination will not be accepted.

# Election

- Once we have received the nomination forms, the names of the nominees will be read out at the AGM. You will then be required to vote for/elect **one** of the nominees on the day of the AGM.
- The nominee who receives the highest number of votes will become the member-elected Trustee. Should an elected Trustee cease to be a Trustee for any reason, the alternate Trustee will fulfil the role of the principal Trustee.
